1st Annual KICK THE DAMM SPOT 2009 Kick-A-Thon

Saturday, June 6th, 2009

Our annual kick-a-thon is a fun and fit activity for kids of all ages (including adults), with all children reaching for their personal best scoring record. The kids will set realistic scoring goals based on age and development. Refreshments will be provided, and each participant will receive a token of participation as well as an opportunity to win prizes for the most amount of sponsorship dollars pledged and collected.

Our goal is to raise \$100,000 towards The Steve Damm Fund, The American Cancer Society, and Frisco Family Services. We hope that each family will participate in the KICK THE DAMM SPOT to the best of its ability. If each child raises \$200, we will achieve our goal. Rules

1. Participants may start collecting pledges as soon as they receive the pledge sheets. **Reminder: Pledge sheets need to be turned in on kick-a-thon day, Saturday, June 6th, 2009.**
2. Pledges may be made by anyone. However, participants may not ask for pledges from any of the staff members of Fieldhouse USA. **Please ask everyone who pledges if their company has a matching gift fund policy.** Companies who do match pledge gifts are listed on the back of the pledge sheet.
3. **Each sponsor making a pledge should write their own name, pledge per goal, and maximum pledge.** Participants may collect the pledge in advance but must keep pledges until all are collected. **NO CASH PLEDGES IN ADVANCE PLEASE**
4. On kick-a-thon day, each participant will kick during a specified time period on our field. Each goal is approximately 4 feet wide and the participant will shoot from approximately 5 feet away. Each participant will be monitored during a timed shooting period of 3 minutes.
5. Upon completion of the kick-a-thon, participants will be handed a certificate of completion with the total number of goals scored. A volunteer will record each participant's goal total on their pledge sheet and return it. Participant's may then collect outstanding pledges. **Please return pledge sheets with the money to The Steve Damm Fund by Saturday, June 13, 2009.**
6. All shooting will take place indoors in a controlled environment.
